<u>AGREEMENT</u>

This Agreement is made and executed at Gurugram, Haryana, on this 17th day of May, 2025

BY AND BETWEEN:

Korea Tourism Organization, a company registered under the Companies Act, 1956 under Section 592 and having its registered office at 303, Pegasus One, Golf Course Road, DLF Phase-V, Sector-53, Gurgaon, Haryana- 122003, India, (hereinafter referred to as the "**KTO**", which term shall include its successors, legal representative, executors and assigns) of the First Part;

AND

BENNYS ROYAL TOURS PVT LTD a company registered under companies act 2013 having its registered office at KG Oxford Business Center, Srikandath Road, Ravipuram Kochi, India (hereinafter referred to as "Bennys", which term shall include its successors, legal representative, executors and assigns) of the Second Part;

KTO and **BENNYS Second Party**, whenever the context so requires shall collectively be referred to as "Parties".

WHEREAS:

- 1. KTO is a liaison office as per the FDI/RBI guidelines issued and is engaged in the promotion of tourism of South Korea.
- KTO is conducting 'Korea Premium Travel Consultant, 2025 Program' (herein after referred to as "KPTC 2025 Program") for promotion of "Premium Korea Travel Packages" in India and neighbouring countries namely Maldives and Bangladesh.
- 3. The Second Party is engaged in the business of Leisure travel related services.
- 4. The Second Party has shown its interest for providing marketing services to KTO in order to promote and gather participation for Premium Korea Travel packages for KPTC 2025 Program.

NOW THEREFORE, in consideration of the mutual covenants and terms set forth in this Agreement, the Parties hereby agree as follows:

1. CAMPAIGN

- (i) The Second Party will carry out the promotional activities for Premium Korea Travel packages under KPTC 2025 Program organized by KTO and for that Second Party will execute, manage and deliver the marketing services to KTO.
- (ii) KTO shall provide the Second Party with destination training specific to Premium Korea Travel and on successful completion of such destination training KTO shall provide ecertificate to that effect.

(iii) On completion of aforesaid destination training and being a certified member of the KPTC 2025 Program, the Second Party shall be eligible to avail benefits as mentioned in Annexure-

A attached hereto.

(iv) Scope of Work and Deliverables for KPTC 2025 program is provided in Annexure-A to this

Agreement.

2. GENERAL TERMS AND CONDITIONS

The Parties hereby agree to the following terms and conditions:

(i) This Agreement shall be valid from the date of signing till 10th December 2025 unless mutually

terminated. This Agreement may be terminated at any time by either Party upon 30 days

written notice to the other Party.

(ii) KTO will assist and provide support to the Second Party with resources and information,

wherever required, for marketing activities to be carried out by the Second Party for KPTC

2025 program.

(iii) KTO will provide KPTC 2025 members with incentives, US \$20 per passenger, on case on a

case-to-case basis.

(iv) A souvenir will be provided to each traveler.

(v) The Second Party will use KTO and Imagine your Korea logo / images in their promotional,

marketing materials, wherever required.

(vi) KTO may in connection with the work under this agreement disclose confidential information

to the Second Party. The Second Party shall not, during this Agreement or afterwards, disclose

any of the confidential information to any third party.

3. Jurisdiction: Any dispute, if any, arising from this Agreement may exclusively be submitted to

the Courts of Gurugram, Haryana only.
